FEES EXPLAINED

INITIAL ASSESSMENT	This is an initial, yet comprehensive, consultation and discussion to review your unique care requirements, to align our services and to develop a care plan that will deliver everything that you need. This assessment is undertaken by a qualified Registered Nurse.
HOME RISK ASSESSMENT	This is an onsite visit at your home to assess your home and environment from a work, health and safety perspective to ensure that it is safe for you and our staff that will be providing services there.
MEDICATION REVIEW	This is a discussion between our Registered Nurse, your pharmacist and your GP to ensure that all service providers are working in unison to deliver the care plan.
ANNUAL ASSESSMENT	This is a thorough annual assessment of services being provided to you. Like the initial assessment, this assessment is undertaken to ensure compatibility between services provided to those that you require/would like. Although services can be amended at any time, this assessment ensures that both service provider and client take the opportunity to undertake a formal review.
DOMESTIC & CARE SERVICES	This is the cost of service delivery by care staff. This includes travel and full contact time in accordance with the care plan. Care services are provided by qualified care staff and domestic services are supplied by our experienced domestic services staff. All staff are fully vetted and have been specifically selected due to their alignment with Banksia's core values and mission. Minimum billing period is 30 minutes between 6am and 7pm and is one hour at all other times.
MAINTENANCE & GARDEN	This is a service offered to support clients by meeting some of the maintenance and gardening responsibilities that often become onerous at home. This fee includes travel and use of small equipment such as a whipper snipper and lawn mower.
CLINICAL CARE	This is a service of qualified health professionals that attend to more complex health needs. Our service has a number of Registered Nurses that are qualified and experienced clinical needs' providers.
TRANSPORT	This is a service that provides transport to and from appointments, meetings and/or social events. This service includes a care staff member picking you up and delivering you back to home and assistance with any mobility limitations.
ALLIED HEALTH	We have a wide network of allied health services and professionals available to us. These services are supplied at cost with a small margin.
MISC PURCHASES & WORKS	This is for services agreed between the operator and the client that are outside of our standard service portfolio. Tell us what you would like to us to do or organise. We are flexible and willing to help.
CASE MANAGEMENT	This is a fixed fee that covers the costs of case management works such as routine reviews, coordination of meetings and discussions with you and your family.
ADMINISTRATION	This is a fixed fee that covers all the administrative tasks and costs associated with delivering the care plan, with exception of allied health services. This includes production and delivery of a detailed monthly statement of how you have utilised your funds.
BASIC DAILY FEE	This is a contribution paid by the client. This fee is set by Government and is fixed at 17.5% of the age pension. This fee is currently \$10.43p/day.
